County Health Department or ServSafe Certificate

All food vendors must provide a ground cover. No ground cover-no set up. All grease must be properly disposed of. If caught dumping grease vendor will be immediately ejected and fined. Food vendor must provide their own electricity. Proof of insurance is required. Each generator must be provided with a fire extinguisher with a minimum 40B:C rating

TYPE OF VENDORS BY CATEGORY

-Food: 10x15 space provided to occupy.

(food vendors are required to be within county health department regulations ie: servsafe and or food handlers permit, ground cover, and proper fire extinguisher type: 2A)

-Cart: 10x10 space provided to occupy. Beverages and single snack items (please specify)

-Merchandise: 10x10 space provided to occupy.

-Corporate: 10x20 space provided to occupy. Chains and Franchises are considered Corporate.
